ADVERTISING: We are committed to timely print ads in local and regional newspapers, calendar of events, internet, public announcements, lists in print, broadcasting and Michigan tourist publications.

DATE: Saturday, July 19, 2008 from 10:00 AM to 4:00 PM. Registration and set-up, starts on Friday, July 18 **AFTER** 2:00 PM until dark (9:00 PM), Saturday morning at 7:00 AM. **Register before setting up and receive your booth assignment. Register at the Information Booth.**

MEDIA: This is a juried show open to fine arts and selected crafts. **NO BUY/SELL ALLOWED.**

JURYING: Applicants must submit 3 photos of current work, 1 photo of booth setup and 1 of work in progress. Photos or digital photos printed on photo paper are acceptable. 8x10 are preferred, 5x7 accepted. Label each photo with artist's name, media and an arrow indicating the top of the photo slide. Prior participants are **NOT** automatically accepted.

S.A.S.E. Include a business size, self-addressed, stamped envelope for the return of your photos and jury results.

BOOTH FEE: Booth size is approximately 12" x 12" and the cost is **\$50.00** per space. Make checks payable to Frankfort-Elberta Area Chamber of Commerce.

DEADLINE: Applications must be received no later than June 1, 2008. Applications will be juried monthly thru June. It is to your advantage to **APPLY EARLY**. Notifications will be sent out after jurying. Applying early increases your chance of becoming an exhibitor.

RULES: A list of rules is enclosed with your application. The rules will be enforced. Limited edition prints signed and numbered are acceptable. The committee has the right to exclude any exhibitor not abiding by the rules, to limit the entries in any category, to remove any work considered inappropriate or not consistent with the rules. No refunds to accepted artists after June 1, 2007.

FOOD: There will be food available on site. Coffee and donuts will be provided for the exhibitors after 8:00 AM on Saturday morning.
